6. **Managers Report including ECO Grant Update**

- PA: The Quarterly Performance Report is included
- PA has met has made searches for a new auditor including speaking to other TMOs
- The figure of £1,8000 per annum that was raised at the previous meeting is an unrealistic figure.PA said we are not going to get anybody for under £3,000. When we have another financial meeting he will recommend GCN whose quotation is included in the Board papers
- ECO grants: The update is attached. Nothing is moving on in terms of a start date. British Gas have sent a contract to BHP which has been scrutinised and an adjusted version sent back to BG. The contract allows for BHP to act as project managers which will give the TMO more control in the day to day planning..
- PA has not heard back from Andy Donald. If PA hasn't heard from him by Friday, then he make a formal complaint.
- Vulnerable Residents Survey: Aging population: 27% of properties have someone over the age of 60 living in them. .
- PA went on a Care Act 2014 conference. The Act outlines increasing responsibilities in safeguarding vulnerable residents. The TMO is already acting with a high level of safeguarding measures in place
- PA: The NFTMO annual conference is in June this year.
- PA: Parking: usually during daytime there are spaces but sometimes, not always overnight the bays are all full. New permits will be issued at the end of March with some clarifications on the use of visitors permits.
- GK: Why don't we charge for parking? PA's response: Next year is probably the time to consider charges as it is currently subsidised.
- PA:. Some waste has been refused to be taken away by the bin men.
- PA: Bin sheds in winter: People are sleeping in there, particularly in the A block.
- JA: Shouldn't they be closed? PA: it has been decided to leave them open. PA: We check them in the morning.
- PA: If we put a key fob on bin rooms it would create further problems with dumping and fire hazzards
- PA has completed the Manager's Report. .
- PA: We are going to have a zebra crossing. There is a joint initiative between Brent and Camden. It is likely to happen after April.
