5. . <u>Treasurer's Report</u>

- PMc: there was nothing unusual to report. On the whole, there was an under spending. It was under by £8,500 for the year to date.
- PA: We have got to budget forward for the next financial year. When ECO happens we will be very busy staff wise..
- RD: Have we had the management agreement back from BHP yet? PA, no. PA saw Christina at Civic Centre. She has been through a third of it.
- PF: Queried mobile phone allowance being included in wages. It is provided to PA and the caretaker on a monthly basis.
- PF: Tree felling costs to staff?. PA did a health and safety assessment and had own staff carry out work for a third of contractor cost.
- KB: Are we to pay Helen anything? We pay her £20 a week for landscape gardening. PA said that she had done a good job of looking after the grounds.
- SL: Are we still going to keep Joe on for the new financial year?
- PA: Joe cuts grass, composts, leaf picks, weeds, prunes hedges and trees and does any other grounds work I ask him. Including brick work as needed. We have got control over the quality. We could get a contractor in for the grounds.
- PMc: With Joe we are getting more quality for money.

6. <u>Manager's Report including ECO Grant update, Rent Performance Report, Minutes from Monitoring and Liaison meeting and Miscellaneous items</u>

- PA: Monitoring Reports: PA had a liaison and monitoring meeting with BHP.BHP are monitoring PA's/TMO performance but overall its more of a liaison meeting than a big brother type of monitoring of performance. Watling Gardens has got the best stats in Brent for rent.
- PA had a meet up at WG with BHPs caretaking manager to compare notes.
- TMO Liaison person is now Omar Jaffe.
- Brent for Friends of Earth are hiring the community hall

- They are going to hold a conference on 10 February 2015 All residents will be invited
- With an increasingly older and vulnerable resident profile PA stated he is more required to provide help and support to this group of people.
- A letter has been sent to Andy Donald and Brent Councillors on 8th January. PA had a meeting with local Councillors. BHP are minded to do a full package of works. Not just BG funded items .They are planning to have a short consultation due to grant deadlines. They are going to approach LVT, and go for dispensation. Christmas.
- RD: The letter was dated 8 January 2015. They have 10 days to respond. The project manager understands that some of the things will be challenged. There is a lot of negotiating to be done.
- PA: Patrick Madigan is an experienced project manager with many years of experience. PA has confidence in his skills and abilities. BHP are going to take on management of the grant funded work.
- PM: BHP will apply for a dispensation. If works went ahead, we would still go to LVT. PM speaks on behalf of the Leaseholders, and they would be more than happy for BHP to come and speak to them.
- RD: 18 January 2015 is a Sunday.19 January 2015 is the deadline for a response
- RD: Have a surgery, meeting with the Housing department and Councillors. We could get the whole Board to come along to the meeting.
- KB: If work starts the scaffolding would come first. Some
 of the amount of money has already come down. The roof
 and boiler need to be done.
- RD: £1.8 m of BHP money is going to be divided into 31 leaseholders, £14,000 per leaseholder. PM came up with 14,754 per leaseholder.
